6. If I wish to insure my quilt against damage, loss, theft or otherwise, I will take the necessary steps to achieve this at my own cost. For the sake of clarification, I understand and acknowledge that no other party will have insurance in place for the quilt/s and that if I desire such insurance, it is my sole responsibility to arrange this.
7. I hereby indemnify SAQG and the other quilting guilds involved in the Exhibition, as well as their members against any claims which may arise pursuant to any loss, damage or theft of my quilt. I waive any and all claims against them of whatsoever nature as well as any all rights to claim from all other parties who lawfully take possession of the quilts pursuant to the Exhibition.
